- 1. Winslow Homer's Homosassa painting, <u>Shell Heap</u> (pictured at right) conveys what the author feels is an intimate and vital connection. How does this painting differ from how people of Homer's time viewed the ocean?
- 2. Mississippi artist Walter Anderson once asked, "Why does man live?" What was his answer and how has that tied to the history and importance of the Gulf?

- 1. What is a "gulf"? What are the comparisons between the Gulf of Mexico and the Mediterranean?
- 2. Why did Rachel Carson refer to the Gulf Stream as an "indigo flood"?

Chapter One: Mounds

- 1. What are some of the requirements of an estuarine region and how do these requirements play a role in the importance of the American Sea?

- 1. Why did Ponce de Leon name what he thought was an island "La Florida"? What do residents of Florida often describe as the reason for the name?

- 1. How did the indigenous peoples of the coast know about the Spanish before the Spanish knew about them?
- 2. What is meant by "Estuaries are the bustling centers of oceans—cities that never sleep"? How could an understanding of this have changed the fate of many early explorers of the Gulf?
- 3. Why was the Texas coast a place that Europeans feared being shipwrecked for centuries?

Chapter 4: A Most Important River, and a "Magnificent" Bay

- 1. What mistake did La Salle make on his first trip down the Mississippi River? How did he convince the Crown to support the expedition via the sea?
- 2. How did modern day southern staples of sweet potatoes and watermelons make their way to the Gulf? What other crops utilized in Southern cuisine were originally farmed by the indigenous inhabitants of the area?
